South Plains Association of Governments (SPAG), Area Agency on Aging (AAA) partnered with the South Plains Chapter of the Air **Conditioning of America** (ACCA-SP) on the "Heat the Town Project", Saturday, October 27, 2012, from 8:00 am-12:00 noon. Heating and Air Conditioning contractors and other business donated time, money and materials to make the repairs free.

The first 60 people to call the AAA were placed on a list for a free inspection of their heating units. This helps the elderly residents in Lubbock as they will feel safe and secure that their heaters are in working condition and ready for the winter.

All receiving the inspections of their heating systems are low-income elderly and disabled residents in Lubbock.

ACCA-SP visited 54 homes and checked the heaters to make sure they were winter ready.

According to the project Chairman, Ron Chambless, the project was successful again this year. He recommends people to get their heating units professionally serviced by a licensed contractor annually. Problems with heating units have contributed to a number of

# **Disaster Relief Awards for Drought Mitigation**

**Crosby County,** Dickens County, Garza County and the City of Crosbyton were all recently notified that they will receive Disaster Relief funding from the Texas Department of Agriculture.

These four entities are all part of the White River **Municipal Water District** which has reached critically low water levels due to severe drought.

Each entity will receive \$350,000 to rehabilitate existing wells and/or to drill a new well to support the existing water system. The projects were submitted for funding in August and the grants officially began in November.

An unexpected addition to these awards was recently announced to include the cities of Ralls and Spur.

These two cities were part of the original disaster relief plan, but funding was not initially guaranteed.

However, the Texas Department of Agriculture's decision to include funding for these projects raises the total project award to \$2.1 million.

The funding cycle for **Disaster Relief begins** again in February 2013, and SPAG Regional Services is happy to assist any community in applying for these funds or determining eligibility.

In order to qualify, an applicant must be within 180 days of losing their primary water supply among other qualifying factors.

# Ralls & Springlake To Receive CDBG Funding

The City of Ralls and City of Springlake will be awarded 2012 Community Development Block Grant funds to provide infrastructure improvements in both communities.

Each city will receive \$275,000 from the Texas Department of Agriculture to be combined with matching city funds to make improvements. The City of Ralls will make water system improvements and the City of Springlake will make improvements to their sewer system.

Both cities applied for funding in the fall of 2010 and scored competitively enough to be awarded in the second round of funding (2012



awards).

The Texas Department of Agriculture made site visits to each community on October 1st and 2nd to review the award and prepare the cities to begin the projects.

SPAG wrote and will administer both of these awards for Ralls and Springlake. For more information on CDBG applications or funding, please contact the Regional Services Department.

# **Law Enforcement Academy Accepting Applications**

The South Plains Association of Governments Regional Law Enforcement Academy is currently accepting applications for the Basic Peace Officer Academy.

The Basic Peace Officer Academy consists of 643 hours of training. The training will equip the student with the necessary knowledge and skills to work as a peace officer in the state of Texas. Successful completion of this academy will allow the student to take the state peace officer licensing exam. We will have two academies starting in January, 2013. The 80th Basic Peace Officer Academy



will start on January 14, 2013, and the hours will be 6:00 PM – 10:00 PM, Monday – Friday. The 81st Basic Peace Officer Academy will start on January 21, 2013, and the hours will be 8:00 AM – 1:00 PM, Monday – Friday. For more information, contact Julie Ryan at 806-762-8721.



# South Plains Regional Urban Search and Rescue Team Training

On October 27, 2012, the South Plains Regional Urban Search and Rescue Team had a full scale search and rescue training. A call went out around 6:00 a.m. stating that the Marvin D. Brewer Fire & Rescue Training Facility had collapsed. Rescue teams were encouraged to respond as if the situation was real, in case they are ever faced with a similar situation in the future.

The purpose of the training was to learn how to safely retrieve and recover victims from collapsed structures utilizing protocols and procedures modeled after the Federal National Incident Management System (NIMS).

Many of the responders brought unique skills that helped contribute to the overall search and rescue effort. Some had knowledge of carpentry while others had knowledge of welding, masonry, and rescue equipment systems. The rescue team was not the only component that was able to practice their skills.





The training included a planning division as well as a logistics team. The purpose of the planning team was to obtain information and disseminate it in the most effective manner. Information from weather, equipment, coordinates, communications, etc. helped contribute to the formation of an Incident Action Plan.

This Plan is the key tool used to keep everyone informed and focused on the objectives. The logistics team practiced obtaining and distributing resources, rehabilitating the search and rescue team, and established points of contact with possible resources outside of the jurisdiction.

The overall exercise has been over six years in the making. Marvin Brewer, along with Bill Durham, David Corder, and Otis Stark, helped initiate this effort over six years ago.

The formation of the South Plains Regional Urban Search and Rescue Team was partially due to the fact that there is no organized search and rescue team on this side of Texas. The only other teams are Texas Task Force 1 out of College Station and Texas Task Force 2 out of Dallas.

Should a natural or man-made disaster occur. it would be several hours before either one of these teams could adequately respond. Incident and emergency responders involved in this effort are hoping that the training equipment available in the South Plains region will be sufficient enough to establish a state-recognized urban search and rescue team. **Chuck Jones from Texas Task** Force 1 was one of the observers during the exercise. He provided the leadership with tips and advice on how to improve the overall response.


